## CUMBRIA STEAM AND VINTAGE VEHICLE SOCIEY LTD

Schedule of conditions applying to all traders During the period of the Cumbria Steam Gathering



- 1. The Society reserves the right at all times to refuse admittance to any Trade Stand Exhibitor.
- 2. Admittance to the event rally field will be strictly on a pre-payment basis: Entry will be refused if this instruction is not complied with.
- 3. Admission. Traders and their staff will be indentified by a special pass issued by the Society and valid for the event days only. Passes must be worn and available for identification by security staff when departing from or returning to the rally site. The gates will be closed from 2300hrs until 07.00hrs, the only exception being access for emergency vehicles.
- 4. Acceptance by the Society of a firm reservation or pre-payment of a rental fee in no way confers any rights whatsoever to the renting trader and in no way modifies these conditions.
- 5. Cancellation of pre-paid bookings will be reviewed upon the merits of each case.
- 6. The site must be left in a clean and tidy condition. Glass, tins, string, plastic wrappings and all other refuse must be placed in the containers or skips provided or placed in other suitable containers for ease of disposal.
- 7. Mock auctions by any trader will not be permitted. Traders in breach of this condition will be expelled from the rally field.
- 8. All trade stand exhibitors must follow the instructions issued by the Society or their designated representatives.
- 9. All traders must have public and products liability insurance cover in place and will indemnify the Society against any claims such as loss, damage or injury arising from any incident however caused.
- 10. All traders must have adequate fire fighting equipment which must be available for inspection by the Society's Safety Officer.
- 11. Traders may only sell items as specified on their booking form.
- 12. Copyright. The words Cumbria Steam Gathering and the logo of the Cumbria Steam & Vintage Vehicle Society Ltd are copyright and may not be used without prior written consent of the Society.

- 13. No sub-letting of allocated sites is permitted.

- 14. The use of public address systems is forbidden.
- 15. All dogs must be kept on a leash at all times and be kept under proper control.
- 16. The allocation of sites and positioning of stand space will be entirely at the discretion of the Society, although every endeavour will be made to meet any request made by a trader regarding the positioning of his or her stand.
  - a) Traders booking open space must apply and pay for sufficient space for all stays or guy ropes required for any building, tent or caravan to be erected within the boundaries of that space.
  - Boundaries of sites will be marked and in no circumstances will traders be allowed to occupy a larger space than that allocated to them.
  - c) Trader's staff must confine their sales activities to the area of their stand and must not use the avenues to solicit business.
- 17. All electrical generators, wiring and appliances should have a current inspection certificate in accordance with I.E.E. regulations and these will be inspected by the Society's Safety Officer who has the authority to prohibit the use of unsafe electrical generators, wiring and appliances.
- 18. Traders are not permitted to sell any item which issues a projectile i.e. crossbows, bows and arrows.
- 19. All traders should acquaint themselves with current legislation and ensure that their activities are carried out in accordance with the Statutory Provisions.
- 20. Any trader who is in contravention of these conditions will not be permitted to trade and will be removed from the rally field with no recompense.
- 21. The riding of cycles during the hours of public access is forbidden and a 5 m.p.h. speed limit is in force throughout the duration of the event. A no vehicle movement policy will apply during the hours of public opening.
- 22. In the event of a dispute the Event Organiser's decision is final.


